The book includes an overview of how EU-neighbouring countries, such as the Norway, Russia and the Energy Community countries, have increasingly influenced EU energy policy and consequently EU energy regulation. It also considers the commercial response to the EU electricity directives, the case law of the European Court of Justice, and an overview of what the future might hold. The interface between EU energy law and investment law and treaties is also considered.
